Privacy Policy

At Blacktoe Medical we are committed to ensuring the privacy of our visitors. This Privacy Policy describes how personal information is collected from visitors of the Blacktoe Medical website at www.blacktoemedical.com, and how such personal information is used and disclosed. By using our Site, you consent to the terms of this Policy.

What is Personal Information?

Personal information consists of "personally identifiable information"; that is, information that specifically identifies a person. Information We Collect and How We Use It
